Ambit Field Service Add-on for SugarCRM

Terms of Service

The **Ambit Field Service Add-on for SugarCRM** is provided under these terms of service, further referred as “terms of service”. The **Ambit Field Service Add-on for SugarCRM** is protected by copyright and other applicable law. Any use of **Ambit Field Service Add-on for SugarCRM** other than as authorized under these terms of service or copyright law is prohibited. By exercising/ using **Ambit Field Service Add-on for SugarCRM**, you accept and agree to be bound by these terms of service. To the extent these terms of conditions may be considered to be a contract, the service provider grants you the rights contained here in consideration of your acceptance of such terms and conditions. If you don't accept these terms and conditions you must immediately terminate the usage of **Ambit Field Service Add-on for SugarCRM** solution of any kind.

1. Definitions

- a. “Service Provider” means Ambit Software Pvt. Ltd., registered in India that offer(s) the **Ambit Field Service Add-on for SugarCRM** under THESE TERMS OF SERVICE.
- b. “You” means an individual or entity exercising rights under these TERMS OF SERVICE who has not previously violated TERMS OF SERVICE with respect to the **Ambit Field Service Add-on for SugarCRM**, or who has received express permission from the Service Provider to exercise rights under these Terms of Service despite a previous violation.
- c. “Distribute” means to make available to the public the original and copies of the **Ambit Field Service Add-on for SugarCRM** through sale or other transfer of ownership.

- a. By purchasing **Ambit Field Service Add-on for SugarCRM** for Identified domain you are allowed to install and modify, develop **Ambit Field Service Add-on for SugarCRM** on one SUGARCRM system and one Domain Identified on your Purchase order, for identified number of users.
- b. You are not allowed to sell, distribute, or reproduce **Ambit Field Service Add-on for SugarCRM** and any part of its source code or library to third party without agreement of the Service Provider.
- c. You are allowed to make modifications to the **Ambit Field Service Add-on for SugarCRM** sources but in no event will the Service Provider or copyright holders be liable for any claim, damages or other liability, whether in an action of contract, tort or otherwise, arising from, out of or in connection with the software or the use or other dealings in the software.

- d. Terms of Service do not allow the part of **Ambit Field Service Add-on for SugarCRM** source code or library to be redistributed as part of another product without agreement of the Service Provider.
- e. Terms of Service may be transferred to another SUGARCRM installation only with prior agreements with Service Provider.

3. Representations, Warranties and Disclaimer

Unless otherwise mutually agreed by the parties in writing, Service Provider offers the **Ambit Field Service Add-on for SugarCRM** as-is and makes no representations or warranties of any kind concerning the **Ambit Field Service Add-on for SugarCRM**, express, implied, statutory or otherwise, including, without limitation, warranties of title, merchantability, fitness for a particular purpose, non-infringement, or the absence of latent or other defects, accuracy, or the presence of absence of errors, whether or not discoverable. Notwithstanding the above, Service Provider reserves the right to release the **Ambit Field Service Add-on for SugarCRM** under different TERMS OF SERVICE or to stop distributing the **Ambit Field Service Add-on for SugarCRM** at any time; provided, however that any such election will not serve to withdraw these Terms of Service (or any other Terms of Service that has been, or is required to be, granted under the TERMS OF SERVICE), and these Terms of Service will continue in full force and effect unless terminated as stated above.
